Their continued importance as spiritual leaders, social counselors, educators, and political mediators underscores their capacity to balance tradition with the demands of contemporary life. This study reaffirms the Kyai Langgar as the bedrock of Ngepoh Village, demonstrating that traditional religious institutions like the langgar are not only capable of withstanding modern pressures but can also serve as powerful agents of cultural and spiritual continuity in a changing world.

As the community faces future challenges, there is a critical need to support the Kyai Langgar's role by equipping them with digital tools and platforms that facilitate a broader and faster dissemination of religious teachings. This would allow the Kyai Langgar to reach more community members and younger generations while preserving the local wisdom and values that define Ngepoh Village. By leveraging both traditional and modern tools, the Kyai Langgar will continue to serve as a guiding force, leading the community through the complexities of modernization with a strong cultural and spiritual foundation. This adaptability positions the Kyai Langgar as an enduring figure of leadership, one who not only preserves faith but actively shapes a resilient and cohesive society, rooted in both heritage and progress.

The findings of this study illustrate the concrete role of the Kyai Langgar in Ngepoh Village, extending beyond their function as educators to include acting as drivers of social and economic initiatives rooted in Islamic values. For example, in informal educational activities, the Kyai Langgar regularly organize religious study gatherings (pengajian) open to all community members, from children to adults. In these sessions, the Kyai discuss not only religious matters but also provide guidance on everyday life issues, such as the importance of honesty in business, respect among neighbors, and family financial management based on Sharia principles. Through this approach, the Kyai Langgar establish a community-based character education model that is not only relevant in a religious

context but also positively influences the attitudes and behaviors of the community across various aspects of their lives. These activities strengthen social bonds and promote character development founded on ethical Islamic values.

Additionally, the Kyai Langgar actively promote economic self-sufficiency within the community by supporting cooperative-based enterprises that emphasize principles of mutual assistance and solidarity. In this capacity, the Kyai teach cooperative members the importance of honesty in business transactions, integrity in financial management, and social responsibility guidance collective welfare. This toward demonstrates how the Kyai Langgar not only convey religious teachings but also apply them practically, directly impacting the economic welfare of the community. Through this approach, the Kyai educate the community in economic ethics, underscoring the role of Islamic education in creating a society that is not only devout but also equipped to address economic challenges based on principles consistent with Islamic teachings.

The contribution of this study to Islamic education in Indonesia is further emphasized by depicting the Kyai Langgar as figures who successfully integrate character education, economic ethics, and social cohesion within a community-based educational model. This holistic approach enriches the understanding of Islamic education, highlighting that its influence extends beyond classrooms or madrasahs to encompass the broader dimensions of community life.

The role of the Kyai Langgar in Ngepoh Village extends significantly beyond their traditional educational functions, positioning them as pivotal figures in the promotion of social and economic initiatives grounded in Islamic values. Their informal educational activities, particularly through religious study gatherings (pengajian), serve as a platform for disseminating not only religious teachings but also practical guidance on everyday life issues. These gatherings foster discussions on critical topics such as honesty in business, respect among neighbors, and family financial management in accordance with Sharia principles. This approach establishes community-based character а education model that is relevant in both religious contexts. thereby positively and secular influencing the community's attitudes and behaviors across various aspects of life (Hayat, 2014; , Alfisyah, 2015)

The Kyai Langgar's commitment to character education is further exemplified by their active promotion of economic self-sufficiency within the community. They support cooperativeenterprises that emphasize based mutual assistance and solidarity, teaching cooperative members the importance of integrity in business transactions and social responsibility towards collective welfare. This guidance illustrates how the Kyai Langgar effectively integrate religious teachings with practical applications, thereby directly impacting the economic welfare of the community. By educating the community in economic ethics, they underscore the role of Islamic education in fostering a society that is not only devout but also equipped to tackle economic challenges through principles aligned with Islamic teachings (Wafaretta, Achadiyah and Firdaus. Sulaiman. 2023); Chusmeru and Masrukin, 2018).

The contributions of the Kyai Langgar to Islamic education in Indonesia highlight their role in integrating character education, economic ethics, and social cohesion within a communitybased educational framework. This holistic approach enriches the understanding of Islamic education, emphasizing that its influence transcends traditional classrooms or madrasahs to encompass broader dimensions of community life. The Kyai Langgar's initiatives not only enhance the spiritual and moral fabric of the community but also empower individuals to engage actively in economic activities that reflect Islamic values, thereby fostering a more cohesive and resilient community (Sarjiyanto, 2024).

# CONCLUSION

The conclusion of this study reaffirms that the transformation of the *Kyai Langgar's* role in Ngepoh Village reflects their remarkable ability to adapt to increasingly complex social, political, and technological dynamics. Despite facing

various challenges, the Kyai Langgar remains steadfast in upholding the religious and moral values that form the foundation of the community, while expanding their influence across educational, political, and social spheres. Their central role as guardians of morality and agents of social change underscores the enduring relevance of traditional religious institutions like the Langgar amid the forces of modernization. Looking forward, there is a need for more strategic efforts to leverage technology and social media as effective tools for religious outreach, preserving the local while wisdom that characterizes Ngepoh Village. Through these efforts, the Kyai Langgar will continue to play a crucial role in guiding the community toward a balanced spiritual and social well-being, cementing their position as a pillar of resilience in the face of contemporary challenges.

This study recommends strengthening the Kyai Langgar's role in Ngepoh Village by integrating digital technology and fostering Utilizing strategic collaborations. digital platforms can extend their religious outreach, especially to younger generations, ensuring relevance in a modern context. Additionally, partnerships with educational institutions and government bodies could integrate Islamic character education into both formal and informal curricula, promoting moral values communitywide. While embracing these modern approaches, it remains essential for the Kyai Langgar to preserve the village's unique cultural identity, maintaining local wisdom and religious principles alongside technological advancements to sustain resilience and authenticity amid contemporary challenges
